JEFFERSON PARISH CODE OF ORDINANCES, CHAPTER 22

SECTION 22-16: HOURS OF SOLICITATION

Even after obtaining the permit, no permittee under this article shall solicit and/or peddle door to door and/or conduct any house canvassing or solicitation between the hours of 8:00pm and 8:00am, except as made by appointment.

SECTION 22-28: PERMIT REQUIRED

No house to house canvassing or salesman or salesladies shall solicit and/or peddle door to door without first having obtained from the Bureau of Revenue and Taxation a permit for such solicitation and/or peddling or canvassing.

SECTION 22-29: PERMIT FEE

The permit fee under this Chapter shall be two dollars (\$2.00) for each applicant.

SECTION 22-30: REVOCATION

Should any person having obtained such a permit, solicit and/or peddle door to door and/or conduct any house to house canvassing or solicitation between the hours of 8:00pm and 8:00am, except as made by appointment, the permit shall be revoked and thereafter the solicitor, salesman, saleslady, and/or canvasser shall not be able to obtain another permit.
