

INMATE VISITATION

The Jefferson Parish Correctional Center (JPCC) allows its inmates visitation rights utilizing a video visitation system for friends and family.

There are two ways to visit through video visitation:

1. At the off-site Visitation Center located at 2211 Barataria Blvd. Suite 110, Marrero, LA 70072.
2. Remotely through your own computer, android or apple device.

Visitation Center Hours are:

Monday through Sunday:

Open 8:30am-1:30PM

Closed 1:30pm-3:00pm

Open 3:00pm-9:00pm

Visiting times:

9:00am - 11:00am

11:00am - 1:00pm

3:00pm - 5:00pm

6:00pm - 9:00pm

Visitation Hours have expanded to allow family and friends more access to their loved ones. Visitation will begin at 9:00am and will end at 9:00pm daily.

Inmates may receive one (1) free video visit weekly at the Visitation Center. A maximum of three adults and three children may visit at the free visit. It is the visitor's responsibility to coordinate who comes to this visit.

Inmates may receive a maximum of three visits per day REMOTELY through the Securus system. This visit is in addition to the one free weekly video visit at the Visitation Center.

Remote visits incur a charge of \$12.99 per 20-minute visit.

Requirements

Visitors must register with the Securus Visitation System at:

<https://securustech.net/steps-to-register>, whether visiting at the Visitation Center or Remotely.

All visits must be scheduled. There will be no walk-in visits allowed. Visits can be scheduled a maximum of two (2) weeks in advance and must be scheduled a minimum of 48 hours in advance.

Visitors must provide a valid state driver's license, state identification, passport or military identification card to visit.

Children over the age of 13 are considered adults and must have a valid school identification card to visit.

Cancellations must be completed 24 hours in advance of the visit. If not the visit will count as completed.

General Visitation Rules

1. Visitation is a privilege. Visits may be denied, revoked, or limited when the visit would threaten safety, security or good order of the facility or when visitation rules are not followed.
2. A person wishing to visit with an inmate will be denied visiting privileges if:
 - a. The Watch Supervisor or Watch Commander considers that person a threat to the safety of the facility.
 - b. The inmate refuses to visit with a visitor or visitors.
 - c. The visitor is abusive to JPCC personnel or is creating a disturbance.
 - d. The visitor is not present at the scheduled time for the visit.
 - e. The visitor is inappropriately attired.
 - f. The visitor(s) become involved in a verbal or physical confrontation with the other visitor(s).
 - g. Visitors that create a disturbance or disruption in the visiting process.
 - h. Visitors who appear to be under the influence of drugs or alcohol.
 - i. Visitors that refuse to show sufficient identification.
3. Bringing firearms, explosives, alcoholic beverages, narcotics or any controlled substances including marijuana into this facility is a crime and cause for arrest.
4. The visitation schedule may be cancelled or altered at any time for safety / security reasons.
5. All non-contact "social" or family" visits will be conducted via video visitation. Either at the Off-site Video Visitation Center (located at 2211 Baratavia Blvd. Suite 110, LA 70072.) or remotely, through the internet.
6. Visiting may be delayed or postponed with good reason and every attempt will be made to forewarn inmates and visitors when possible.
7. Inmates who are on disciplinary lockdown are not permitted visitation.
8. Visitors are required to register with the JPCC Visitation online through <https://securustech.net/steps-to-register> to visit.
9. Visitors are responsible for arranging visits with inmates, online at <https://securustech.net/schedule-an-on-site-visit> or by utilizing the visitation kiosk at the Off-Site Visitation center located at 2211 Baratavia Blvd. Suite 110, LA 70072. **Privileges may be suspended or terminated for inappropriate behavior or misuse of the visitation system.**
10. No video or audio recordings of video visitation by visitors are permitted.

11. Visitors are not allowed to carry cameras, tape recorders, purses, bags, diaper bags, backpacks, brief cases, cell phones, or any electronic device into the Video Visitation Center nor the Correctional Center.
12. For the purposes of security, the Correctional Administrator, Deputy Administrator, or the Assistant Deputy Administrator may declare certain inmates' ineligible for visiting if they present a clear danger or threat to the good order or security of the JPCC.

Video Visitation

1. The Picture and State ID/Driver's License submitted through the Securus Video Visitation system for account verification must be of the account holder ONLY.
 - a. The visitor must have on appropriate attire in the account picture.
2. The account holder information in the Securus Video Visitation System must match the information on the State ID/Driver's License
 - a. The State ID/Driver's License must be current for visits to be approved.
3. Video Visitation (with exception of privileged visits) will be monitored by JPCC personnel and recorded. Violations of Law will be investigated and may be prosecuted.
4. The visitor who schedules the visit is considered the primary visitor and must be present at the time of check in and for the visit, and must remain on the camera at all times.
5. No more than (3) Adults and (3) minor children per visit at the Video Visitation Center.
6. When scheduling a visit, list the correct number of children and adults, no substitutions may be made the day of the visit.
7. Repeat cancellations or no shows will be subject to evaluation and possible suspension of visits.
8. Inmates may receive a maximum of three video visits in each 24-hour period, based upon time slot availability.
9. Video Visitation must be scheduled 48 hours prior to the visit, but may be scheduled a maximum of two weeks in advance.
10. Any inappropriate activity will result in termination of your session.
11. No food or beverages are allowed in the Video Visitation Center.
12. No loitering at the Video Visitation Center.
13. Only persons with a scheduled visit or using scheduling kiosks are allowed in the Video Visitation Center.
14. No minor children shall be left unattended.
15. All cancellations must be completed 24 hours in advance of the visit or the visit will count as a completed visit.
16. Visitors and inmates must remain seated at all times during the visitation session. Small children, three (3) years old and younger, must remain on the visitor's lap at all times.
17. Minor children are the responsibility of the parents or guardian and shall not be allowed to run unsupervised prior to nor during the visitation period.
18. The account holder must remain in the video picture at all times during the visit.

19. No inmates other than Inmate scheduled for the visit are allowed on the video visit.
20. Use of any type of electronic device during a visit is prohibited, excluding the device being used to conduct the visit.
21. No "FaceTime" or Third-Party calls are allowed during a visit.
22. Visitors who record visits and/or post them on the internet will be banned from the visitor center permanently.
23. Online remote visitation restrictions:
 - a. No acts that encourage sexual behavior.
 - b. No nudity or disrobing during the visit. Visitors must be fully dressed.
 - c. Explicit or profane language or any suggestive or sexually explicit language is prohibited by all people in the visit.
 - d. The use of any sexual hand, mouth or body gestures are prohibited.
 - e. No acts or behavior that are criminal under state, local, or federal statute.
 - f. No gang signs or acts that encourage or promote gang activity.
 - g. Hands or other objects are not to be used to cover the mouth to block what someone is communicating.
 - h. Smoking and Drinking is prohibited during the video visit.
 - i. Any other irrational behavior that is deemed as inappropriate or perceived as a threat to the safety and security of the facility.
24. Visitors caught abusing equipment will face criminal charges.
25. Visitors who appear intoxicated or are misbehaving will not be allowed to visit.
26. Sharing of a Securus Visitation Account with another person is prohibited.

Visitor Dress Code

Visitors can dress in casual attire according to climate conditions; however, they must abide by the following:

1. **No** short shorts.
2. **No** swimwear, halter tops, tube tops, or tank tops.
3. **No** mini-skirts.
4. **No** see-through blouses.
5. **No** hats or head gear will be worn unless medically necessary.
6. **No** bare midriffs.
7. The appropriate length of shorts, skirts, dresses, shorts will be no shorter than the tip of the middle finger when standing with arm down to side of leg.
8. Dresses with spaghetti straps are not allowed.
9. No loose pants. Neither underwear nor buttocks may be visible.
10. Appropriate footwear must be worn, no bedroom slippers.
11. Skin tight / Form fitting clothes are not allowed.
12. Any clothing or other items displaying gang-related symbols, themes or colors are prohibited.
13. Any clothing containing vulgar or objectionable language or images are prohibited.
14. All visitors must wear undergarments at all times.

15. No excessively torn jeans with exposed skin above the knee allowed.
16. No pajamas.
17. All buttons, snaps, and zippers will remain fastened.
18. Supervisors are the final authority in determining appropriate dress.
19. Visitors cannot wear any garment that exposes the shoulders, chest, back, stomach, midriff, and/or underarm. Necklines must be within two inches of the notch of the neck.
20. Clothing made of sheer, transparent, net, or mesh materials is not allowed.
21. Clothing designed or intended to be tightly worn, to excessively accent the body (e.g., spandex, tights, leggings, tank tops) is not allowed.
22. Appropriate undergarments are required, and should not be visible.
23. **No** clothing that is revealing in any way will be allowed during visitation.

All people appearing in the video visit must be fully clothed including children and babies.

Attorney Visitation:

1. Attorneys representing inmates in criminal proceedings in Jefferson Parish may visit in person with inmates at the Correctional Center, or may utilize the video visitation system via privileged visits.
2. Privileged visits are visits that are not recorded and monitored. These are visits with Criminal Attorneys, District Attorneys, and Law Enforcement Agencies.
3. Attorneys wishing to utilize the Video Visitation system either at the Visitation Center or Remotely must:
 - a. Register within the Securus Video Visitation System through the above link and request to register as a Privileged Visitor.
 - b. Provide a picture of current identification AND current Louisiana BAR Association card.
4. Attorneys representing inmates in any other matters must utilize the video visitation system.

Parking

Off-Street parking is available for free in the parking lot at the Visitation Center.
